

Annex B Terms & Conditions of NETS 2024 Scratch & Win at Haniffa 10 Oct – 11 Nov 2024

The NETS 2024 Scratch & Win at Haniffa ("**Promotion**") is carried out by Network for Electronic Transfers (Singapore) Pte Ltd ("**NETS**") and is subject to these terms and conditions ("**Terms**").

- The Promotion is open to all existing DBS/POSB, HSBC, OCBC, Maybank, Standard Chartered, UOB ("Participating Banks") and NETS bank cardholders, including the employees of NETS and employees of the Participating Banks (collectively referred to as "Customers").
- 2. The Promotion period is valid from 10 October -11 November 2024, both dates inclusive ("**Promotion Period**") unless otherwise stated.
- 3. The Promotion is valid at Haniffa outlets in Singapore which are registered with NETS and/or the Participating Banks and accepts payment through Qualified NETS Bank Card and/or Qualified QR Applications (defined below). - 4. NETS may from time to time in its absolute discretion decide on the eligibility of a Participating Outlets or Customer for participation in the Promotion.

 - b. "Qualified QR Applications" shall mean the Participating Banks' QR payments mobile applications (which include NETSPay, DBS PayLah, DBS digibank mobile app, POSB digibank mobile app, UOB TMRW, OCBC Pay Anyone[™], OCBC Digital and Standard Chartered Mobile Banking App)

- 12. The Promotion is available for purchases made at manned cashier counter(s) at Haniffa Participating Outlets and not valid for online ordering or self-service kiosk purchase.
- 13. The Promotion is valid only for full transactions via NETS, and is not applicable for deposit payments or partial payments.
- 14. The Promotion is not valid in conjunction with other promotions. All promotions are mutually exclusive.
