

Terms & Conditions of NETS x OG CNY Promotion (26 December 2024 – 28 January 2025)

- 1. The Promotion is open to all existing DBS/POSB, HSBC, OCBC, Maybank, Standard Chartered, UOB ("Participating Banks") and NETS bank cardholders, including the employees of NETS and employees of the Participating Banks (collectively referred to as "Customers").
- 2. The Promotion period is valid from 26 December 2024 28 January 2025, both dates inclusive ("**Promotion Period**") unless otherwise stated.
- 3. The Promotion is valid at both OG Department Stores at OG Albert and OG People's Park in Singapore which are registered with NETS and/or the Participating Banks and accepts payment through Qualified NETS Bank Card and/or Qualified QR Applications (defined below). - 4. NETS may from time to time in its absolute discretion decide on the eligibility of a Participating Outlet or Customer for participation in the Promotion.

- b. "Qualified QR Applications" shall mean the Participating Banks' QR payments mobile applications (which include NETS App, DBS PayLah, DBS digibank mobile app, POSB digibank mobile app, UOB TMRW, OCBC app and Maybank2u SG (Lite) app).
- 6. The Promotion is available for purchases made at manned cashier counter(s) at OG's Participating Outlets and not valid for online ordering or self-service kiosk purchase.
- 7. The Promotion is valid only for full transactions via NETS. Not applicable for deposit payments or partial payments.
